Kathy Gans, Senior Vice President of Ajilon Professional Staffing, is a 20-year veteran of the staffing industry. The Chicago native joined Ajilon in 1998 as Area Vice President in Orange County California. While in that role, she developed a reputation for hiring and developing key Ajilon talent and in 1999 won the first of her three "Vice President of the Year" awards from Adecco's North American subsidiary.

In 2001, Kathy was promoted and moved back 'home' to Denver, where she began her staffing career two decades ago. Shortly after returning to the Mile High City, Kathy became a member of Ajilon's executive team, which oversees company policy and strategy. Currently, she is responsible for hiring, training and developing teams for Ajilon's central zone of the United States. Kathy has participated in various national and regional training sessions, sits on a number of company-wide task forces and has been member of the Denver IMA since returning to Denver.

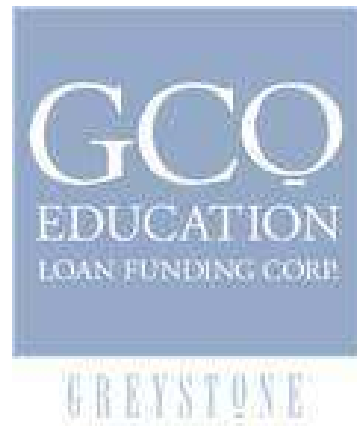

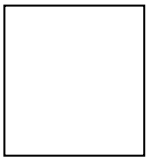

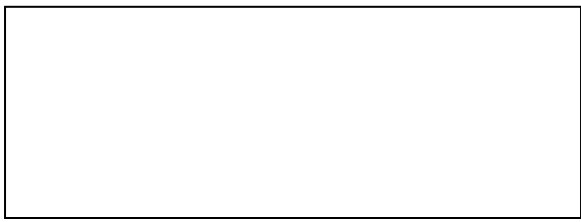
